Rules & Regulations:

- 1. The odd & even rule is not applicable on B.Tech 1st year.
- 2. If subject is being offered in current semester:
 - a) On-roll students have to deposit fee of Rs. 1500/- per subject and is allowed to fill maximum two (02) theory and two (02) practical detainee subjects in current semester.
 - b) Eligible ex-student(s) has to deposit Rs. 2,000/- per subject and is allowed to fill maximum five (05) theory papers and three (03) practical detainee subjects in current semester.
- 3. If subject is not being offered in current semester:
 - a) Final semester student(s) has to deposit fee of Rs. 15,000/- per subject and allowed to fill maximum two (02) theory and two (02) practical detainee subjects with the recommendation of the concerned Head of Department and permission of the Principal.
 - b) Eligible ex-student(s) has to deposit Rs. 15,000/- per subject and allowed to fill maximum five (05) theory and three (03) practical detainee subjects with the recommendation of the concerned Head of Department and permission of the Principal.
- 4. If the subject is not being offered in the current study scheme then student may be allowed by respective Head of Department to clear the detention, subjected with the condition that the subject having syllabus content minimum 80% similarity offered in the department(s) and fee of Rs. 1500/- per subject for on-roll and Rs. 2000/- per subject for ex-eligible students is applicable.
- 5. In any case which is apart from those mentioned above, the case must be recommended by respective HoD to Academic Section at the earliest.
